#### PROJECTS AND SERVICES

Walking with your children in a park. Dashing down a basketball court. Mowing your lawn. We usually do not think about our ability to move, bend, lift, throw or push without limitation. But an impairment, injury or illness can take away those abilities, and suddenly everyday activities become extraordinary tasks.

Rehabilitation is the process of restoring a person's ability to live and work as normally as possible after a disabling impairment, injury or illness. It aims to help the affected person achieve maximum possible physical, functional and psychological fitness and regain the ability to be independent. It offers assistance with the learning or relearning of skills needed in everyday activities, with various ongoing training support and guidance.

Rehabilitation is an integral part of convalescence. Proper food, medication, and hygiene and suitable adaptation provide the physical basis for recovery. The affected person is encouraged to be active physically and mentally to the extent recommended by the health care team. Medical and nursing care, physical therapy, occupational therapy, speech therapy, special education, assistive devices and vocational training are used extensively in the rehabilitation of the person with disabilities.

#### THEMATIC AREAS OF OPERATION



Early identification and intervention



The mission of Early Childhood Intervention is to assist families who have at-risk children to receive a range of services and supports in maximizing their child's physical, cognitive, and social/emotional development. The service is provided with sensitivity with respect to parents from diverse families and communities. This programme runs every day throughout the year.

The following are provided by Asha Bhavan Centre early intervention services:

- Identification of children with disabilities.
- Screening.
- Assessment in all development areas.
- Management programmes in all areas of individual's needs.
- Training to family members.
- Medical services.
- Mental health support through counseling for children, parents, and families.
- Nursing care services.
- Nutritional services.
- Occupational therapy.
- Parent training and education.
- Physical management.
- Social work services.
- Speech-language and communication services.
- Assistive devices and services.
- Community Based Rehabilitation Programmes.
- Vision services identification of children with visual disorders or delays through referral and follow up services.
- Audiology identifying children with hearing impairments and provision of referral services for evaluation and other necessary services.

## Therapeutic management

To restore, maintain and promote optimal level of physical and function abilities. Our therapeutic programmes include physical management and rehabilitation, individual detailed physical and functional assessment, and identifying specific individual abilities and needs. Based on the needs of the individual, we formulate the management programmes, with each component implemented accordingly. This programme also provides aids and appliances, focusing on (i) postural correction in all positions including functional activities; (ii) mobility aids, including wheelchairs, and equipment required for feeding, writing and communication. Accessibility is a key element in the multidisciplinary approach to enhance a child's ability in physical and functional development areas.

Our goal of physical management is to help individuals:

- Improve physical abilities to an optimal level
- Help the child to become independent in functional activities as much as possible
- Improve mobility and accessibility
- Prevent possible deformities and contractures which are likely to occur
- Improve self-esteem and confidence
- Minimize pain and discomfort

### Occupational therapy (OT)

This is an important component of the rehabilitation programmes towards meeting the needs of the individuals. It includes the design and development of equipment and special furniture, including the equipment required for meal-time management. It also provides training for occupational skills development, aiming for specific vocation for individuals to be able to have a profession. Lastly, it helps to design and develop educational and communication equipment so people with disabilities can participate in social events, be visible in the community, and additionally reduce the environmental barriers in society.

Speech therapy and total communication for children who do not have spoken language is an important component of rehabilitation. Many conditions, including cerebral palsy, autism, hearing loss, or developmental delays, may cause difficulty with speech and language development. Some children may not understand language. Some children may understand language but be unable to communicate effectively due to difficulty with speech. And sometimes children experience challenges in other areas of communication, such as sign language, gestures and facial expressions. This programme aims to improve speech and language skills and oral motor abilities.



For non-verbal children this programme provides communication boards and other systems for enhancing their speech and communication. Additionally, we help children build their confidence by using these communication skills and aides, and promoting the learning of new words, learning to speak in sentences, or improving their listening skills.

#### Behavioral therapy

This is also an integral part of the programmes for those who needs modification of their behaviors. Regular assistance can help to modify behavioral problems and promote adaptation skills. Behavioral therapy uses psychological techniques to improve physical, mental, and communicative skills.



#### Vocational training

Special education

This programme is designed for students who have a variety of disabilities, such as an intellectual disability, cerebral palsy, delayed development, or any other disability (other than blindness). This aspect of "delay," broadly categorized as a developmental delay, signifies an aspect of the child's overall development (physical, cognitive, social skills) which places them behind their peers. Due to these special requirements, students' needs cannot be met within the traditional classroom environment. Special education programmes and services adapt content, teaching methodology and delivery instruction to meet the appropriate needs of each child.

This is a process which enables persons with disabilities to overcome barriers to accessing, maintaining or returning to employment or other useful occupations. Vocational rehabilitation can require input from a range of care professional's disciplines such as vocational instructors, disability employment advisers and career counselors.

The vocational training division of Asha Bhavan Centre caters to adults with disabilities with a view to secure suitable long-term employment, with an ultimate aim of integrating or re-integrating the person into the community. ABC trainees have demonstrated their innovative ability in a variety of creative and art skills, handmade paper production, and tailoring.

#### Networking

Asha Bhavan Centre (ABC) has established networks in the districts of West Bengal and across urban areas. It has also been involved in networking amongst the government departments in the state of West Bengal, and also across the Indian Central Government and Non-Government Organizations (NGOs), This networking has been extremely successful to create cooperation between Asha Bhavan Centre to create various opportunities for the person with disabilities.

#### Referral and follow up services

ABC believes in collaboration and always refers children to other organizations whenever necessary. We have established linkages with the State Government, The Commissioner of Persons with Disabilities, Departments, National Institutes for disabled, Government Hospital other NGOs, and relevant corporate stake holders.

#### Education

Asha Bhavan Centre imparts formal elementary education for the rural pupils in a structured environment whose explicit purpose is teaching them. Usually, formal education takes place in a school environment with classrooms of multiple students learning together with a trained, certified teacher of the subject. Our school systems are designed around a set of values or ideals that govern all educational choices in that system. Such choices include curriculum, organizational models, design of the physical learning spaces (e.g. classrooms), student-teacher interactions, and methods of assessment, class size, educational activities, and more.



Asha Bhavan Centre initiate its first Teacher's Training College in Howrah district to create manpower for impart quality education and to become a greater nation.

The D.Ed.Spl.Ed. (MR) course recognised by Rehabilitation Council of India (RCI), Ministry of Social Justice and Empowerment, Govt. of India, aims to develop professionals for Special Education within a broad framework of education in the current millennium. The course will enable learners to acquire knowledge, develop competencies and practice skills to impart education arena.

The methodology of the course includes lectures, demonstration, project work, and discussions, exposure visits to different schools / rehabilitation projects, participation in community meetings, medical camps and community development programmes, practice-teaching in the disability intervention programmes at grassroots level.

Certification as Registered Personnel, It is mandatory for every rehabilitation professional / personnel to obtain a "Registered Personnel / Professional Certificate" from the Rehabilitation Council of India to work in the field of special education in India. As continuous professional growth is necessary for the renewal of the certificate, the rehabilitation professional / personnel should undergo in-service programme periodically to update their professional knowledge.

#### Health

Even after decades of freedom, India is struggling to provide basic health services to its people. According to government sources, in India 45 children die every hour due to respiratory infections. 1 child dies every 2 minutes due to diarrhea. And annually, about 2 million children under 5 years of age die due to preventable diseases.

The situation calls for timely care and diagnosis which can reduce the incidence of morbidity and mortality especially among children and women.

The Community Health Programme provides healthcare services to meet the immediate health care needs of the marginalized community in remote rural areas through a medical clinic. The outpatient health programme offers comprehensive health services – curative, preventive, promotional and referral services, to a large number of people in the community.

## **Community Development Programme**

Community development is action that helps people to recognize and develop their ability and potential and organize themselves to respond to problems and needs, which they share. It supports the establishment of strong communities that control and use assets to promote social justice and help improve the quality of community life. It also enables community and public agencies to work together to improve the quality of government.

Women Empowerment: Though Women's rights are secured under the Constitution of India, yet the status of women in India has been subject to many great changes. Asha Bhavan Centre works to the creation of an environment for women where they can make decisions of their own for their personal benefits as well as for the society. The organization provides empowerment training, various workshop, vocational training programme and events.

Again, inclusion of children with disabilities with the mainstream education system initiated in our education project as a Mission to bring about transformation in the society to make our society more just, more equal, more Humane and more harmonious. This year one more success we have achieved. Our children with disabilities participated in the National Para Olympic Competition organized at Jaipur, Rajasthan and won gold, silver and bronze medals.



### The Message of Bro. Gaston Dayanand



Dear brothers and sisters of Asha Bhavan Center (ABC),

It seems impossible to me to tell you year after year, how much I love you all, secretary, director and your family, workers, members, well-wishers, and of course above all, your beautiful but suffering kids, my own great-grand-children...

You know also quite well how much I appreciate your work, because of its efficiency, deep thinking, original and even genial way in preparing schemes, your audacity to propose to Rehabilitation Council Of India, Government of India gratitude that the families of children have towards your care, your compassion, your sharing and your love, and eventually, the appreciation the donors themselves have to you because they feel so proud to help ABC, especially our dearest Dominique Lapierre and his wife.

From the very beginning of your long march towards 'excellence', I told you some essential things that so many social workers nowadays forget:

- Devote your priority not to build something nice, but to give love to the inmates and transmit dedication to your staff.
- 2. Never forget that, whatever we do or want to do belongs already to God and that He alone can help you achieve your aim of service to the suffering physically or mentally challenged. Because alone, you cannot do anything really beautiful. You need the inner strength offered by God.
- 3. Always remind your professional brothers or sisters first to think about the persons they want to help, and not the ways they have learnt to help.
- 4. And eventually, accept in advance the praises (awards, etc) or the backlashes in complete equanimity, feeling satisfied that you have given your best to achieve your aim.

In our social work, it is never the end which is the more important, but the ways we perform our duties. Better 20 children loved that 100 children unloved or neglected. Better not to be the best professional if you are not the best lover of the patients. I do recognize that many NGOs seem to be extremely successful, but when examining their outstanding computerized methods internationally praised, we realize that the output is only quantitative, that the beneficiaries are far to be satisfied, and that the essential inclusive endeavour is missed.

Dear Sukeshi and John-Mary, keep on giving your time and your life as you have done up till now, during more than 40 years for the first and some 17 years for the second, and you would have fulfilled the very aim of having found A NEW WAY OF BEING SOCIAL WORKERS. Some may not agree, but close the ears to the jealous gossip and follow the Arabic proverb: "The jackals howl, but the caravan passes".

# Story of change:

Sumana Paikar was born in 1999 in a remote village name Sasati of Howrah district. She is the eldest child in her family. The father is the principal breadwinner and he works as a local chef. The happiness of having a baby faded when they noticed the differences of Sumana; and after visiting with various doctors, she was diagnosed with Cerebral Palsy. Sumona required intensive care for her development. When her baby brother came when Sumana was just 3 years old, she became neglected by her parents. Eventually Sumana was discovered by Asha Bhavan Centre and brought under the umbrella of the residential care service. When she came under the service she was unable to sit and was dependent for her daily care. Since 2005 she is receiving a range of rehabilitation supports and is now able to walk independently and be fully independent for her daily living activities. Sumana attends the community school, plays with her female peers, and also helps other hostel residents to become independent.

Asha Bhavan Centre is proud to announce that 3 athletics from our organisation, who participated in The National Para Athletic 2017, held at Sawai Mansing Stadium, Jaipur, Rajasthan, have bagged 1st, 2nd & 3rd prizes in the Shotput game of the event.

Sumona Paikar, who is 17+ years old and suffering from 60% cerebral palsy, was awarded a Gold medal. Whereas, 17+ year old Neha Khatun, afflicted with 75% cerebral palsy, won a Silver medal. Rupa Pramanick, the youngest of the lot, who is just 16 years old and has a staggering 80% cerebral palsy, received a Bronze medal for her achievement.

Due to poor economic conditions, and lack of access to services, her parents were unable to provide her with proper support. She first came to Asha Bhavan Centre at the age of 6 years, and has stayed there since. Before this period she was unable to move, stand or walk. Receiving regular occupational therapy, physiotherapy, and other therapies from our Asha Bhavan Centre, Sucharita is now able to do her Daily Living Activities and can walk with a mobility aid indoors. She is also able to write her name and address. Her parents are very happy to see her improvement. We wish her success that she leads a full life.

### Community Based Rehabilitation (CBR)

This year the project reached 22 blocks of 6 districts. From Morning to Evening, the unit works to improve the quality of life of people with disabilities within the community. # Story of change:

Ankita is an 8 year old with Cerebral Palsy. She is at win, yet sadly her brother died after two days of birth. Ankita is from a family comprised of 9 members from Jadurberia village, under Uluberia block-I of Howrah district. She has an elder brother, studying inclass VII. Her father earns about 5000/- INR per month (equivalent to USD \$80). Ankita was brought to ABC at the age of 4 years. When she originally came she was able to control her head and was learning to sit. She was dependent on her mother for all functional areas such as eating, drinking, toileting, washing, bathing etc. Her mother was confused about her problems and came seeking medical treatment.

Asha Bhavan Centre's staff initiated her management programmes after detailed assessment, covering all her priority needs, including preschool skills with periodical review and updating her profile and modification to the programmes as required.

At present Ankita is able to walk with crutches and special shoes (Ankle Foot Orthoses). She has been attending the mainstream school about 2 kilometres away from her house and enrolled in class-I. Now she has learned to eat with her hand (customary in India) and drink from a glass on her own. She is independent with toileting, although still needs some help with washing after. She is independent in washing her face and brushing her teeth. She enjoys bathing, and engages herself independently in bathing with support. She enjoys playing with dolls.

Tulu Pal, Ankita's mother, is a different person after receiving this support. She is confident and happy with the progress made by her daughter. She is hopeful she will continue studying and will be able to achieve higher education. She is thankful to Asha Bhavan for the guidance and support she has received.

We also promote these children for inclusive education whenever possible and provide extra support as and when required. In 2006, when she was 7 years old, her parents took her for admission to class two at Bodhoday Vidya Mandir, Sekhalipara of Murshidabad district. Since the beginning, the motivation shown by Baby towards her classroom learning helped the teachers of BVM to realize her nascent talent. Gradually she completed her primary education in the year 2009 achieving 1st position in all classes and took admission in Dakshinnagar High School (HS) for higher education. There, she was able to put indelible mark of her genius. This year, 2017, Baby passed the Higher Secondary examination with 'A+' Grade securing top rank with 83.40% marks. The Management of Asha Bhavan Centre is proud of her achievements.

To achieve this, Baby had to fight all odds, and face numerous challenges head on. The financial situation of the family is miserable and hardly anybody's guess. She lives with her parents in a small room in a vested land and her parents maintain their livelihood by making' Bidis' (handmade cigarettes). In her leisure time Baby also helped her parents in household work. Yet, in spite of extreme poverty, her parents made a supreme sacrifice to continue Baby's education. Now, Baby has the eager desire to continue her education in graduate level which has disconcerted her parents considering the expenses of college education. We all hope that Baby, the vibrant girl, with her indomitable spirit will excelin life and help to dispel the hopelessness of her household and bring smile to the faces of her parents.

## Rehabilitation Council of India Approved D.Ed.Spl.Ed.(MR) Course

In the month of May 2016 we got approval from Rehabilitation Council of India (RCI) to start the training college for Diploma in Special Education for Mental Retardation "D.Ed.Spl.Ed.(MR). The course is fully self-financed and we have 25 trainees intake capacity. The class is running by 04 core faculty and other various guest faculties. The training is going 5 days in a week as per RCI norms and guideline. Two among the 25 students are having disability and took part equally in the training programme.

The general objective of the course is to prepare teachers at primary and upper primary levels to serve in the following settings:

- i) 2-year Diploma in Education (Special Education) shall also be eligible for appearing in the Teacher Eligibility Test (TET).
- ii) Special schools.
- iii) Integrated/Inclusive School.
- iv) Itinerant programmers.

### Eligibility:

Students who have passed 10+2 or equivalent with 50% of marks (45% Marks for SC/ST/OBC/PwDs Candidates) in any stream are eligible for the course.

## Orthopedic Workshop

This project works with professionals and modern scientific technology to supply assistive devices for people with locomotor disability. The project reaches people with disabilities through camps and referrals. This project involves assessment and casting for aids and appliances as per recommendations by the therapist and orthopedic doctor. It also involves the department purchase of necessary materials and manufacturing. And finally it provides the finished device trial and provision to the beneficiaries with appropriate gait training; and demonstration for maintenance to ensure the long lasting and effective use of the aids and appliances.

# ACHIEVEMENTS, NEWS & EVENT

#### Community sensitization programme

The Community Based Rehabilitation department of Asha Bhavan Centre organized Community Sensitization Programme in the project catchment area in the districts of Coochbihar, Murshsidabad, Birbhum, Purba Midnapur, Howrah and South 24 Pargana districts. During our intervention programmes we learnt how people with disabilities and their families face problems regarding various issues in the village area due to lack of information. As such, we organized various community sensitization programmes with community key influencers and common village mass to create awareness about the various schemes and provisions and facilities regarding services for people with disabilities. More than 2,500 people from the area participated in these programmes, which aimed to provide an understanding of disability issues and available services for the rehabilitation of disabled children. It was meaningful for programme participants to understand the causes of disability and preventive measures for reducing the rates of disability. They also learnt about what services are required for disabled people and how they can help them to integrate in the community. We hope that the programme has helped to create a better understanding of acceptance for people living with disabilities.

#### A step to reach the unreached in North Bengal

Asha Bhavan Centre is glad to inaugurate its Eleventh Community Rehabilitation Centre under CBR program supported by Dominique Lapierre Foundation at Ghoksadanga of Coochbihar district. On 19th July in presence of various distinguish guest and the representative of Asha Bhavan Centre the centre was dedicated for the Person with Disability of that area. The centre will run in the place of Sri Sri Ramkrishana Sebashram of Ghoksadanga twice in a week.

#### Appliances distribution camp pochagarh, Coochbehar

The Orthopedic workshop and Community Based Rehabilitation department jointly organized an Aids and Appliances distribution camp at Community Rehabilitation Centers. 5 such camps were organized during this financial year where we distributed 305 appliances among 123 children with disabilities in the community.

#### Capacity building training programme for service providers

Asha Bhavan Centre organized a capacity development programme for its service providers to keep them updated and abreast of the trends of Rehabilitation in Indian and abroad. Such programmes were organized at New Digha and at ABC Training Hall, Keoradanga, South 24 Parganas and in Kathila campus. The staff members of CBR and Education, Training Division and Residential centre participated in those programmes respectively. Our professional teams were also sent to participate in various state and national level seminars and workshops to upgrade their knowledge, skills and attitude for offering better services to people with a disability and in the community.

#### Parents' training programme

As we know that parents are the best care givers for their child we always give priority to parents and work with them as equal partners for the development of the child with disabilities. Therefore we continue our endeavors to develop their knowledge and skills so that they are able to support their children in the best possible way. The parents' training programme is one such effort which is organized twice in a year in all our community rehabilitation centres under CBR programme.

We conducted 42 sensitization programmes for parents, with more than 1,200 parents participated. In those programmes we discussed various issues regarding disability and the rehabilitation management. We helped the parents to identify the needs their children may have and suggested ways of improving their daily routines.

#### Research program for a Child with Cerebral Palsy (LEAP-CP)

Early detection and intervention is almost the priority area regarding the rehabilitation of a child with Cerebral Palsy. For the context of our country community based rehabilitation involving the parents would be the best mechanism to deliver the rehabilitation. To give a shape and understand the outcome of this approach Asha Bhavan Centre to partner with Queensland Cerebral Palsy and Rehabilitation Research Centre, The University of Queensland Australia for a "Community-based parent-delivered early detection and intervention program for infants at high risk of cerebral palsy (LEAP-CP) in Uluberia – I, Bagnan – II and Shyampur – II Block, Howrah District, West Bengal India. Through this project we screen the high risk baby less than 10 months to detect Cerebral Palsy through the latest diagnostic tools Precht'l General Movement and Hammersmith Infant Neurological Examination. After the detection the programme will be start to recover the impairments through home based parents delivered intervention programme. The programme will be end in 20 months and the outcome will be measure to ensure the effectiveness.
